Conditions of Entry

- Exhibitors must pay full regard to section organisers and marshals instructions and conduct themselves in a manner which will not inconvenience or endanger other persons at any time.
- Entries must be presented in a clean, complete and safe working condition.
- All entries must be insured to a minimum of third party risk, and road vehicles must be fully licensed (where applicable) and tested in accordance with the regulations for the type of vehicles for the road.
- Owners must ensure all drivers are fully competent and qualified in law to handle the class of vehicle exhibited.
- Unlicensed drivers will not be permitted to drive any vehicle, however powered, on the show field, camp field or parking field. The same laws apply on site as on the public highway.
- Passengers must not ride on vehicles or trailers on the show field, camp field or parking field unless sitting on properly constructed seating.
- No exhibit may be left running unattended and all unattended machinery must be left securely braked or choked.
- Exhibitors must not move any vehicle on the show field other than to and from the arena during public opening times without permission of relevant section organiser.
- A maximum speed of 5 M.P.H. shall apply to all vehicles moving on the rally site, and special care taken with regard to pedestrians and young children.
- No additional vehicle may be brought onto site without prior permission from section organisers. Parking will be available nearby.
- Fuel is not permitted to be transferred on any field occupied by the show.
- Campsite will be accessible from Friday 16th August, please vacate by noon Monday 19th August.
- The Campsite Marshall will instruct the parking of units in accordance with caravan club guidelines. Minimum of 3 metres between units.
- Charcoal barbecues will not be permitted on the show field, camp field or parking field.
- Details of acceptance and entry passes will be sent in due course. A pass permits entry for two people; additional persons will be required to pay normal admission fee of £5 adult, £2.00 under 16 & Senior Citizens.
