- We purchased a large amount of fence rails for repair of the Meadow fence. PLEASE help us maintain the fence by replacing any rotten or fallen rails in the fence behind your home.

- Watkins Landscaping will maintain the entrance beds.
- The Meadow will be mowed and harvested 2-3 times a year by a local farmer. They will keep the harvest and share a portion with the horse owners.

Community Safety

Reminder about the roads...

SPEED LIMIT is 25mph throughout our community. When passing pedestrians or cyclists slow down even more!!! Children are extremely unpredictable and many pedestrians may have listening devices, and may not hear you coming. Patience and Caution is worth a life!

-Pedestrians need to be reminded to walk facing the oncoming traffic.

-Cyclists need to remember to ride with the traffic.

-ATVs and motorized bikes are prohibited on public

streets (State Law and County Ordinance). We, as a community, do not allow anyone to ride ATVs on our common property!



Please Curb Your Dog! It's the Law

There continues to be numerous reports of dogs accosting people as they walk down our streets. People should not have to walk in fear! Dogs are causing damage to neighbors ponds, gardens and even screened-in porches. Please be respectful of your neighbors and your dogs by keeping them in your yard. We are encouraging homeowners to report this violation to the County. The County will issue warnings and fines to the owners if they continue not to comply with the county leash law. Mowing Manners

Try to direct grass clippings back into your yard so there is not clogging of the storm drains or hazardous debris in the road. Also, please try to keep on top of trimming the weeds and edging the curbs at your property.

If you are dumping yard clippings in the community woods, please try to spread the debris out so not causing a huge "dump" area. It will break down more naturally, and look better if spread out.





Questions to the Community

We need information from the community members:

The Board is doing an inventory of the Barn and there are several items stored there and we are unsure of the ownership. The barn is a great place to store items that cannot be stored at your home. We just need to know so we can contact you if needed. Currently there is hay/straw that doesn't belong to our current horse owners, a fold-away camper and a trailer. If you are storing anything in the Barn please let one of the Board members know.

We are currently in an effort to create storage space for community members and we may need to do a bit of rearranging so that we can make better use of space. As a board, we have made the commitment to provide an area for storage of recreation vehicles of community members; (boats, RVs and horse trailers). We are offering the shelter and security of the large barn, and the soon to be improved parking pad that is accessible to the meadow and pasture areas. This will allow our community members to be compliant with Declaration of Covenants & Restrictions.

Yard Waste—Dumping is not composting

One subject brought up at the annual meeting was the continued dumping of yard waste in the woods. This has been going on for a long time and it has currently built up to look like a dump. When taking yard waste into the woods please disburse the grass clippings or leaves so that they are not just dumped into a pile. Also, it will help the decomposition of the leaves if they were mulched before spreading.

In the past, at the Community's expense, equipment has been used to push the pile deeper into the woods. This was also brought up at the annual meeting. This is certainly an option, but it is difficult to justify since not all homeowners use this as a dumping area.

This type of dumping creates a fire hazard as well as homes and breading grounds for undesirable creatures. In an

effort to keep our community beautiful please consider the following options.

Harford Sanitation offers yard waste pick up. The pick up is on Wednesdays. You can opt for once a week up to 6 bags for \$10 per month or you can opt for a one time pick up of 6 bags for \$8 (.50 for each additional bag if you have more than 6). They also pick up bundles (count for 1 bag). They must be tied and no longer than 3 feet in length. http://harfordsanitation.com or 410-838-5472

The Barn and Open Space

It is a continued effort to keep the common areas beautiful. Please volunteer when you can!

The 2007 MCA Board decided to truly investigate what the future of our barns should be. Is it worth the upkeep? Has it met it's demise? Last Spring we had a structural engineer give us a full report on the safety of our barns, and recommendations for repairs (in order of necessity) so the barn is safe for animals, people and possibly storage of large vehicle and feed. We are pleased to inform the community that the barn is in pretty good shape, and over the next few years, as funds allow, we will work to maintain the structural integrity and aesthetics of the barns.

Last year the gutters and fascia

boards were replaced on the large barn and recently, a rotted out structural post was replaced. We still have water issues under the large barn, pasture and riding ring, which we are dealing with the State to correct. In the future road work will be done to insure that the drainage problem from Rt. 23 is fixed, the ditch and pipe cleared, and the road will be equipped with a run-off curb, so the excess water runs to the creek and not our land. Soon after, we will ensure that the grading around the barn is appropriate, and the run-off from the new gutters is properly directed.

~There are more minor repairs as well as general maintenance to be done to the barns and surrounding area. They will be performed as



needed and as funds allow.

We are happy to report the barn is structurally safe and sound.

The Parking Pad

There is still work to be done to the designated parking pad. Hopefully it will be ready for use very soon.
